Children's Defense Advocacy - The Council serves as the specialized juvenile public defender in Mecklenburg County. Through a contract with the NC Office of Indigent Defense Services, the Council's attorneys represent all children charged with crimes in juvenile delinquency court. In addition to performing the public defender role in juvenile court, the Council represents every child that is facing confinement in a mental health institution. As express interest attorneys, the Council provides the voice of the child and fights to ensure that their constitutional and statutory rights are protected. The Council is the only specialized juvenile public defender in North Carolina.

Systems Advocacy - The Larry King Center for Building Children's Futures (LKC) works with the community to develop comprehensive community plans to drive systemic change for children. The LKC compiles research on evidence-based services that impact leading indicators of child safety, health and education. Through a community driven process, the LKC effects change in service delivery, impacts expenditures of government and private funding and improves public policies that affect children. The LKC's initial priorities include improving school readiness, reducing the incidence and impact of child abuse/neglect and increasing access to health and mental health care.

Individual Advocacy - The Council's attorneys and advocates serve as best interest advocates for children who are in need of services. These advocates work in the complex areas of special education, mental health, abuse/neglect, public benefits, domestic violence and juvenile delinquency. The Council receives cases through a court order from a district court judge or through parental consent from a concerned parent/guardian that contacts the Council's office. The Council helps clients navigate the difficult social service system so that they can receive appropriate services to meet their needs. When advocacy and other intervention efforts are unsuccessful, the Council files impact litigation on behalf of an individual child to ensure that his/her legal rights are protected. The Council specializes in working with children that have complex needs in multiple social service systems, who are at risk of languishing or falling through the cracks.

Form 990, Part III, Line 4d - Other Program Services Description

Custody Advocacy - The Council serves as the court-appointed Guardians ad Litem (friend in court) attorney to represent the best interests of children who are caught in the middle of high conflict custody cases. Using a combination of staff attorneys, volunteer attorneys and volunteer child advocates, the Council ensures that the child's voice is heard and that the judge has all the necessary information to make a decision that is in the best interest of the child. The Council receives cases through court appointment from a district court judge; this program operates only through court order. The Council's custody advocacy services are provided on a court-ordered fee based on the income of the parties. The Council represents only the child - not the court or the parents.

The Council for Children's Rights Executive Committee met to review the Executive Director's compensation for fiscal year 2009-10. The committee used several salary survey sources (The Employers' Association, United Way and the current salaries of the Executive Directors for eight similarly situated local non-profit agencies) to benchmark compensation for the position. In addition to the salary survey data, the committee consulted with the Children's Intermediary Organization funders to discuss the new responsibilities of the position for fiscal year 2010. These funders provided input into a suggested compensation level for the Executive Director based upon their research with similar national organizations. The effective date of January 1, 2009 aligns with the commencement of funding from these organizations to support the new structure of the Council for Children's Rights and the new role for the Executive Director.
