## **CUSTODY ADVOCACY TRAINING**

The Custody Advocacy Program (CAP) of the Council for Children's Rights (CFCR) advocates in family court for the *best interests* of children in high conflict custody litigation cases in which parental conflict and other issues are or can be in the way of the best interests of the children. You can become a part of this unique and rewarding program that seeks solutions for children during a very difficult, stressful and sometimes fearful time in their lives. CAP volunteer attorneys and custody advocates receive intensive training covering various aspects of this specialized program, including: guidelines for representing children; the local family court rules; divorce and its effects on children; child development; interviewing, facilitation, and negotiation with parents and their attorneys; and expectations outlined by the members of the local family court judges. This seminar is for **attorneys** who are interested in pro bono representation of children, as well as **paralegals** and other **community members** who are interested in serving as custody advocates. (Note that attorney representation does not require courtroom experience or first chair courtroom participation.) This training is required for all CAP volunteers. Attorneys and paralegals will receive **7.75 hours of general CLE or CPE credit (CLE and CPE credit approval pending)**.
